1. The kinds of Personal Information we collect

- 1.1 The kinds of Personal Information that we collect include:

- 2.1 We collect Personal Information by various means including when:

3. The purposes for which we collect, hold, use and disclose Personal Information

- 3.1 We collect, hold and use Personal Information in order to:
- 3.1 Provide our product(s) to you;
- 3.2 Direct market to you, with your permission;

- 3.3 Understand and analyse our sales, and your needs and preferences;
- 4. The parties to whom your Personal Information is disclosed
 - 4.1 Subject to our confidentiality obligations, we may share some relevant Personal Information with:
 - 4.1.1 parties we engage to provide you with goods or services on our behalf;
 - 4.1.2 our email marketing provider for the purposes of providing you our newsletter, invitations and updates; and
 - 4.1.3 third party service providers who assist us with archival, auditing, accounting, legal, business consulting, website or technology services.
 - 4.2 We also will disclose your Personal Information if required to do so by law or in circumstances permitted by the Privacy Act.
 - 4.3 We do not disclose Personal Information to overseas recipients.
- 5. Opting out of marketing communications
 - 5.1 We may, from time to time, send you newsletters, invitations and legal updates about our product(s). You can opt out of receiving further such communications by notifying us using our contact details below by clicking the "unsubscribe" option at the bottom of any marketing e-mail received from us.

6. Security

• 6.1 We take reasonable physical, technical and administrative safeguards to protect your Personal Information from misuse, interference, loss and unauthorised access, modification and disclose.

7. Access/correction/updating Personal Information

- 7.1 You can contact us to access, correct or update your Personal Information. Unless we are subject to confidentiality obligation or some other restriction on giving access to the information and we are permitted to refuse you access under the Privacy Act, we will endeavour to make your information available to you within 30 days.
- 7.2 In addition, our employees and the contractors who provide services related to our information systems are obliged to respect the confidentiality of any Personal Information held by us.
- 7.3 If you request to correct your Personal Information, we will correct, or, if we consider more appropriate, note your request for amendment of the information on your record.
- 7.4 We will not charge you to make a request to access your record but we may charge you to actually provide access depending on the costs associated with obtaining and providing the material.
